Commuting Solutions Hosts 10th Legislative Breakfast

Leaders from across the region gather for a morning of transportation advocacy

LOUISVILLE, Colo – Transportation played a pivotal role in the 2018 midterm election and the past two legislative sessions and it serves a critical role in the economic vitality of communities throughout the northwest metro region. On January 9, 2019, state legislators, the US 36 Mayors & Commissioners Coalition, and business leaders will gather for Commuting Solutions’ 10th Legislative Breakfast at the Lionsgate Event Center in Lafayette for a morning of advocacy on transportation priorities for the northwest metro region.

As stated by Commuting Solutions Executive Director, Audrey DeBarros, “Commuting Solutions 10th Legislative Breakfast is an opportunity for public and private sector stakeholders to convene with elected officials, private sector leaders and agency directors throughout the state to continue the conversation surrounding transportation funding and mobility as the 2019 legislative session begins.”
