well-utilized by, those who call our region home. We work to hasten the day when transportation no longer contributes to climate change.


REGIONAL COMMUTING TRENDS

More than 65% of drivers in Boulder County drove alone while more than 75% of drivers in Broomfield County drove alone, according to a five-year estimate from the Denver Regional Council of Governments.

In Boulder County, 7% carpooled, 4.8% took public transportation, 4.18% rode their bike, 4.96% walked and 12.81% worked from home.

In Broomfield County, 6.9% carpooled, 4.46% took public transportation, .48% rode their bike, 1.06% walked and 10.63% worked from home.

2021 Top 10 Accomplishments

Advocacy for the Northwest Metro Region through Annual (Virtual) Trip to Washington D.C. and State Legislature

Commuting Solutions, members of the Northwest Mayors & Commissioners Coalition and other stakeholders headed to Washington D.C. virtually in 2021 to advocate for the northwest metro region. In addition, we were actively involved in the state legislature and position talking including supporting SB21-260, the landmark transportation funding bill.

2 Completed the CO 119 First and Final Mile Study

In 2021, Commuting Solutions worked with its consultant, Fehr & Peers, local governments, businesses and state transportation agencies to complete the CO 119 First and Final Mile Study, which created corridor-wide recommendations for bicycle and pedestrian connections, shared parking, Transportation Demand Management and microtransit.

3 Continued Northwest Area Mobility Regional Planning Progress

Commuting Solutions worked with local governments, businesses and state transportation agencies to further the Northwest Area Mobility Study by working on the US 287, CO 7 and CO 42 corridor projects. There were meetings throughout the year, updates on social media, information in newsletters and dedicated webpages for the projects.

4 Launched Downtown Superior Modes

In August, Commuting Solutions launched its Transportation Demand Management program Downtown Superior Modes in coordination with the Town of Superior and Downtown Superior to help create sustainable commutes for residents, visitors and employees/employers in the area.

5 Continued to Build the CO 119 Coalition

Commuting Solutions continued to build its CO 119 coalition by working with local governments, businesses and transportation agencies to advocate for the CO 119 corridor project. There were membership meetings for the project, communications through newsletters, emails and social media as well as public involvement.

6 Federal Funding Collaborations

Commuting Solutions worked collaboratively on multiple grant applications to further the multimodal transportation options in the northwest metro region.



Commuting Solutions had the privilege of working with new partnerships and expanding its memberships. We welcomed new members throughout the year. We held more than 20 events including Membership Meetings, Workplace Commute Ambassador Meetings, the 12th Legislative Breakfast, the 5th Sustainable Transportation Summit, webinars, RTD Rider Appreciation events and more!

8 Expanded the Bike-n-Ride Shelter Program

Commuting Solutions worked with the City and County of Broomfield, the City of Westminster and RTD to expand the Bike-n-Ride Shelter further along the U.S. 36 corridor to open two new shelters.

9 Continued to Promote, Support the Ride Free Lafayette Program

Commuting Solutions continued to work with Boulder County, the City of Lafayette and Via Mobility Service to provide a free, door-to-door resource for the City of Lafayette and a portion of the City of Louisville. We provided marketing and social media resources to promote a continuously successful program.

10 Advocated and Educated about Employee Trip Reduction Program

Commuting Solutions advocated and educated members, stakeholders and partners on the importance of Employee Trip Reduction Program (ETRP). The program was not approved, but Commuting Solutions and partners across the Denver northwest metro region continue to explore other plans and ideas to create sustainable transportation options.
